i Cycle track.

It was reported that the bins are not being emptied regularly by WBC. It was decided to ask WBC for their routine schedule and to monitor the emptying to see it accords with the schedule.

v Christmas tree and lights.

It was decided to approach the new owners of the Fox so that the tree can be put in the same place as last year. The tree will provisionally be lit on December 9th at 7.00pm.

vi Village Hall.

The proposed new Hall has been granted planning permission. Match funding for construction of a new Hall has been promised by Greenham Common Trust. It was decided that any Council decision to provide or withold funding to the new Hall would only be taken by the full Council of eleven members.

vi Tennis Courts.

A draft plan was considered for tennis courts by the proposed new Village Hall. Land ownership would need to be established before this could be taken further.

vii Football pitch.

The pitch is being used by visiting teams. It was decided to approach WBC to see whether, if the Council wished, it would be possible for ownership of the whole of the land used by both the pitch and the proposed new Village Hall, to be assumed by the Council along with the commuted sum for maintenance from Miller Homes.
