# 1 Apologies for absence.

There was an apology for absence from Lt Col Sherrington.

## 2 Minutes of the last Annual Parish Assembly held on April 21<sup>st</sup> 2011.

There was a proposition from the floor that the minutes be taken as read. This proposition was put to the vote and carried. The minutes were signed as correct by the Chairman.

## 3 The reports from the Parish Council by the Chairman and the RFO.

### 4 The report from the West Berkshire Councillor.

The report is attached. Questions were then invited.

Forest Edge development is going ahead -- is WBC expanding the School.

It depends on how the balance is between the Senior and Junior Schools.

Does the plan to build 20,000 houses in West Berkshire by 2026 still stand.

The strategy has all been changed by the Local Plan and the Public Examination as to the soundness of the Plan takes place later this month.

The S.106 funds for the Forest Edge expansion includes £220k for Education.

The way that monies are allocated through the system has changed and this may no longer apply. Have residents been contacted.

WBC has advertised the process and it is on the WBC website.

If the Hermitage residents don't want new houses why should the Forest Edge development go ahead.

The decision rests purely on underlying planning policies, remembering that the site was originally given consent as an industrial development. There were applicants for industrial development units. In the future we will need land for development to provide employment.

WBC can only deal with applications as they are presented.

There are a number of children from outside the area who attend Hermitage Schools.

If children live in the catchment area they are entitled to do so.

#### 5 The Military Base.

The Chairman welcomed the Quartermaster from the Base.

There is a concept to refurbish the play park, so that children from all over the area could play together. The funding would come from WBC and the MOD. There should be formal agreement to the WBC funding at the end of the month.

The future of the base is more difficult to forecast.

In 2014 one Regiment will move, but the Royal School of Military Survey is due to stay. The School welcomes many students from all parts of the Armed Forces.

There should be some small areas of the base which may become available for Community use.

There will be no closure before 2017.

There is every possibility of a long term possibility. Any child from Hermitage can use the play park.
