ii S.106 funding and open space development.

The Council feels strongly that the priorities are to get the football pitch seeded and the changing rooms built as soon as possible. An action plan would be compiled for consideration at the next meeting.

Some S.106 funding should be kept back to provide for a disability survey at Pinewood play area together with possible improvements at Pinewood.

A new path at the Burial Ground might also be needed.

It was decided to compile a questionnaire for the APA to get a feeling for things on which the Village would prefer to spend S.106 funds.
